Bidders should note of the following:

- Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as provided in RA 10531 and its IRR; and ANECO Online Procurement Policy as approved by NEA.
- Cooperative will only accept bids from those bidders that paid the non-refundable fee for the Bidding Documents.
- Bidders or authorized representative/s that failed to attend the pre-bid conference or failed to submit waiver of rights to participate in the pre-bid conference will not be allowed to participate in the bidding.
- Bidders or authorized representative/s coming from outside Caraga Region shall be required to present before ANECO security guard a Negative Rapid Antigen Test or RT-PCR Test Results having five (5) days validity period and submit copy to the BAC secretariat upon entering the bidding venue.

ANECO also reserves the right to reject any or all bids without disclosing any reason, to waive any minor defects or infirmities therein and to accept such bid as may be considered most advantageous to the cooperative.
