- Notice of Award - 5 days from the date of confirmation of the Lowest Calculated & Responsive Bid
- Contract Preparation & Signing - Within 5 working days after issuance of Notice of Award
- Notice to Proceed - Within 5 working days after Contract Signing

Bidders are required to attend a pre-bid conference via Zoom to be conducted at QUEZELCO I Boardroom on March 30, 2022 at 1:00 PM where technical requirements will be discussed.


All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid.
