3. **Pre-Bid Conference is scheduled on March 28, 2022 at 10:00AM** at the DASURECO Hilltop Gym, Main Office, Barangay Cogon, Digos City which shall be open to prospective bidders via video conferencing only.

Pursuant to the Proclamation No. 1021 and STRICT implementation of social distancing due to the COVID-19 pandemic, the Procurement Service is equipped with a facility that uses **video conferencing facilities** to continuously communicate and collaborate with stakeholders, hence, there shall be NO PHYSICAL MEETING between the prospective bidders and members of the BAC.

Once the payment has been made, all interested parties may access the Pre-Bid Video Conference call through a link or meeting I.D. which shall be provided directly to your email before the start of the meeting. Potential bidders who access the link shall be required to input their attendance in this format, **name, company**, and **contact details** as normally required in physical meeting.

5. **Bidding proper and opening of bids shall be on April 5, 2022** at 10:00 o'clock in the morning at DASURECO Center for EC Member-Consumer-Owners, Barangay Cogon, Digos City via video conferencing only.

6. Bidding Documents which contain the Terms and Conditions can be purchased at BAC Secretariat for **Php10,000.00, non-refundable**, at the DASURECO Main Office, Cogon, Digos City during office hours from March 12, 2022 up to April 4, 2022 from 8:am to 5:00pm. Only those who have purchased the Bidding Documents shall be allowed to participate in the virtual pre-bid conference and raise or submit written queries or clarification. Likewise, bidding forms and bid proposals can only be submitted to the same BAC Secretariat before the scheduled opening of bids.

7. **DASURECO reserves the right to accept and/or reject any Bid, to annul bidding process, and to reject all Bids at any time prior to the contract award, without thereby incurring any liability to the affected Buyer/s.**
