3. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail criterion as specified on the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives (IRR of RA 10531).
5. Interested Bidders may obtain further information from BAC Secretariat, Angeleen A. Albao/Janine S. Nachor and inspect the Bidding Documents at the address given below during office hour, Monday to Friday before the opening of Bids.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents is **Php 10,000.00**.
7. CASURECO III will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at **CASURECO III Board Room, San Isidro, Iriga City** which will be open to all interested parties who qualify and **who have purchased bidding documents.**
8. Bids must be delivered to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the BIDDING DOCUMENTS FOR THE HIRING OF SECURITY SERVICES FOR THE YEAR 2022.
