- 6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents is **Php 10,000.00**.
- 7. CASURECO III will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at **CASURECO III Board Room**, **San Isidro**, **Iriga City** which will be open to all interested parties who qualify and **who have purchased bidding documents**.
