PANELCO I shall have the authority to suspend the work wholly or partly by written order for such period deemed necessary, due to force majeure or any fortuitous events or for failure on the part of the Contractor to correct bad conditions which are unsafe for workers and for the general public to carry out valid orders given by PANELCO I to perform any provisions of the contract or due to adjustment of plans to suit conditions as found necessary. The Contractor shall immediately comply with such order to suspend the work wholly or partly
