2. The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Eligibility Requirements – Annex B.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail criterion as specified in the implementing Rules and Regulation (IRR) of the Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bid prices that exceed the ABC shall be disqualified outrightly. There shall be no lower limit to the amount of the award.
4. Interested Bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below during office hour, Monday to Friday on or before Pre-Bid Conference.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount stated above.
6. LANECO will hold a Pre-Bid Conference (date and time stated above) at LANECO Boardroom, LANECO, Sagadan, Poblacion, Tubod, Lanao del Norte, which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or **their authorized representative through a written authorization duly notarized.**
7. Due to the threat of Covid-19, bidders have the option to come personally following the health protocols or join via ZOOM during the Pre-Bid Conference and Opening of Bids.
8. For Bidders who opt to join via ZOOM, they must confirm at least three (3) days before the Pre-Bid conference and Opening of Bids to the BAC Secretariat to facilitate the registration of participants and zoom details of the Bidding. Bidders should sign in one (1) hour before the start of meeting.
9. Bids must be delivered to the address below on the date and time specified above. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Item No. 11 of the Bidding Documents.
10. *The Lanao del Norte Electric Cooperative, Inc* reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award on any of the grounds enumerated under R.A. 9184, without thereby incurring any liability to the affected bidder or bidders.
11. Prior to the signing of the Contract, the winning bidder shall post a performance security as specified in the Bidding Documents.




