Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the **NEA Memorandum 2017-019** otherwise known as the "Revised Procurement Guidelines and Public Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)."

Interested parties shall submit their " Letter of Intent" and must comply the accreditation requirements. Deadline of accreditation will be on **April 25, 2022**. There is a non-refundable accreditation fee of FIVE THOUSAND PESOS that is valid for one (1) year.

Only those bidders who have purchased the Bidding Documents are qualified to participate during the pre-bid conference where their presence is MANDATORY. However, due to COVID-19 pandemic, the attendance for both pre-bid and opening of bids will be through video conference via Zoom link.

NORECO I further reserves the right to accept or reject any bid and all proposals, to declare a failure of bidding, and to reject all bids prior to contract award, without thereby incurring any liability to any bidder or bidders or to any party.
