
Bidders should note of the following:


1. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as provided in RA 10531 and its IRR; and ANECO Online Procurement Policy as approved by NEA
2. Cooperative will only accept bids from those bidders that paid the **non-refundable** fee for the Bidding Documents.
3. Bidders or authorized representative/s that failed to attend the pre-bid conference or failed to submit waiver of rights to participate in the pre-bid conference will not be allowed to participate in the bidding.
4. Bidders or authorized representative/s coming from outside Caraga Region shall be required to present before ANECO security guard a **Negative** Rapid Antigen Test or RT-PCR Test Results having five (5) days validity period and submit copy to the BAC secretariat upon entering the bidding venue.
