To qualify, interested bidders must submit electronic copy stamped with certified true copy in case of photocopied documents such as but not limited to: Company profile; Notarized statement in matrix form of all ongoing and completed government and private contracts (supported with purchase orders, job orders, etc.) including contracts awarded but not yet started, if any (**for the last three years**). Statement identifying the bidder's single largest completed contract similar to the contract to be bid within the relevant period as provided in the bidding documents with a value of at least 50% of the ABC (supported w/ contract, cert. of completion, project cost & cert. of acceptance), Copy of By-laws, Notarized statement of availability of key personnel and equipment, Notarized statement that prospective bidder is not blacklisted by any government or non-government agency; DTI Business Name registration or SEC registration certificate; Audited Financial Statements stamped received by the BIR for the immediately preceding year; Certificate of BIR Registration; Valid and current Mayor's Permit and Taxpayer's Identification Number.



Submission and receipt of bids through electronic means are allowed as provided in the Government Policy Board (GPBB) Resolution No. 09-2020 dated May 7, 2020. However, personal submission and receipt of bids are also allowed.

QUEZELCO II reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
