**CEBU III ELECTRIC COOPERATIVE, INC. (CEBECO III)**, through its **Bids and Awards Committee (BAC)**, hereby invites all interested manufacturers, suppliers, dealers, contractors, and authorized franchised dealers who are clothed with a valid PCAB License to submit their respective bids for the Supply of Labor and Materials for the Sitio Electrification Program funded under the 2021 General Appropriations Act as approved by the National Electrification Administration as described hereunder:

1. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
2. A Single-Stage: Two-Envelope Bidding Procedure is to be used to evaluate the technical responsiveness and the Bidder's qualifications before opening the price proposal.
3. The prospective bidder must have completed within five (5) years prior to the bid opening a Single Largest Completed Contract (SLCC) that is similar to Construction of the Distribution Line and Installation of kWh Meters, Duplex Service Drop Wires and Housewiring Materials, and whose value, adjusted to current prices using the National Electrification Administration Price Index, must be at least fifty percent (50%) of the ABC.
4. The presence of bidder during the Pre-bid Conference is optional.
5. Complete set of bidding documents may be secured from the BAC Secretariat upon payment of non-refundable bidding fee. Soft copy of the bidding documents will be provided via e-mail.
6. Bids received in excess of the ABC shall automatically be rejected at bid opening.
