5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents per Lot such as the following: **Lot 1 – Php 10,000.00** and **Lot 2 – Php 10,000.00**

CASURECO III will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at **CASURECO III Function Room, San Isidro, Iriga City** which will be open to all interested parties who qualify and **who have purchased bidding documents**, but if there will be any travel restrictions or stricter health protocols, the Pre-Bid Conference and/or the Opening of Bid will be conducted through a Zoom Meeting (Zoom Meeting ID will be provided accordingly by the BAC Secretariat to the bidders who have purchased the bidding documents).
7. The Delivery Schedule/Completion of Project is within **90 days for Lot 1 and 60 days for Lot 2**, upon receipt of Notice of Award (NOA).
8. The Cooperative shall not be obliged to give any clarifications requested by a prospective bidder who failed to attend the Pre-Bid Conference.
9. **The Camarines Sur III Electric Cooperative (CASURECO III)** reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
