**INVITATION TO BID FOR THE ACQUISITION OF SERVICES
OF AN INDEPENDENT CERTIFIED PUBLIC ACCOUNTANT (ICPA) FOR 2016 TAX
ASSESSMENT (FOR REBIDDING) AND 2017 TAX ASSESSMENT**

The Tarlac I Electric Cooperative, Inc. (TARELCO I) would like to invite eligible Independent Certified Public Accountant (ICPA) having sufficient government accounting and auditing experience to submit a proposal for the examination and verification of our Teller's Official Receipts and Statement of Accounts and other documents as may be required to satisfy the substantiation requirement of the Court of Tax Appeals (CTA), a Judicial Affidavit shall also be executed by the ICPA regarding the result of examination. We require that the ICPA have experience handling tax cases before with the CTA.

Bidders are required to bid per lot.

Lot 1 2016 Tax Assessment	₱ 3, 600, 000.00 Must be inclusive of Admin Fee and Court Appearance Fee
Lot 2 2017 Tax Assessment	₱ 3, 500, 000.00 Must be inclusive of Admin Fee and Court Appearance Fee

Source of fund for the subject procurement shall come from the General Fund.

Quoted price must be inclusive of VAT. The court shall give thirty (30) days completion period from date of commissioning.

Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to Five Thousand Pesos (₱ 5, 000.00) per lot for the cost of bidding documents.

All fees must be deposited to the BAC's bank account to be provided by the Secretariat. A scanned copy of the deposit slip must be emailed to the Secretariat, once the payment was confirmed, an electronic copy of the bidding documents and official receipt shall be emailed to the prospective bidder.

A complete set of bidding documents may be purchased starting **June 2, 2022 until 4:00 P.M. of June 8, 2022** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference through a videoconferencing using zoom app shall be held on **June 9, 2022 2:00P.M.** at the TARELCO I Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **June 8, 2022**. Questions and clarifications not submitted on or before the given date shall not be entertained during the Pre-bid Conference.

Bidders shall send their sealed proposals via courier and must be received by the BAC on or before **12:00P.M. of June 13, 2022**, proof of shipping must be submitted to the Secretariat as evidence. Bid Opening shall be live streamed via zoom app on **June 13, 2022 2:00 P.M.** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

The meeting ID and password shall be sent to all bidders' email address three (3) days before the schedule of pre-bid conference and bid opening. Only one (1) access per company shall be allowed.

Bidding shall be conducted through public bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives.
