1. The **Occidental Mindoro Electric Cooperative, Inc., (OMECO)** through the approved NEA CAPEX Loan intends to apply the Approved Budget for the Contract (ABC) to payments under the contract. Quotations received in excess of the ABC shall be automatically rejected at the Opening of Sealed Canvass.
2. OMECO now invites bidders to apply for eligibility and to quote for the *Emergency Procurement of Supply, Delivery, Construction, Installation and Commissioning of 10 MVA Substation at Pulang Lupa, Brgy. Central, San Jose, Occidental Mindoro* are required within **Ten (10) calendar days** from receipt of Notice to Proceed (NTP) and Purchase Order (PO) and shall be delivered in OMECO Main Office, M.H. Del Pilar St., Brgy. Poblacion VI, San Jose, Occidental Mindoro.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion. Bidding is open to all OMECO's Accredited and Non-Accredited Suppliers, provided that Non-Accredited Suppliers must submit required accreditation documents listed in the **Accreditation Check List Requirement and Accreditation Fee amounting to Three Thousand Pesos Only (Php 3,000.00)** as provided.
4. Request for Quotation (Sealed Canvass) is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
5. Interested Suppliers may obtain further information from OMECO – Bids and Awards Committee (OMECA – BAC) at the contact given below from **8:00 AM to 5:00 PM (office hours), Monday to Friday (except Holidays)**.
6. A complete set of Sealed Canvass Documents may be acquired by Interested Suppliers from **June 3, 2022 until June 6, 2022** from the address below.

7. OMECO will hold a Pre-Bid Orientation/Conference on **June 07, 2022, Tuesday at 9:00 AM** at the OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Due to the uncertainties brought by the current public health crisis (COVID-19), the BAC will conduct the pre-bid conference virtually via ZOOM.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

8. Quotations must be duly received by the BAC Secretariat at the address below on or before **June 17, 2022, Friday at 8:00 AM**.

Opening of the Quotes shall be on **June 17, 2022 at 9:00 PM** at OMECO Main Office, M.H. Del Pilar St., Brgy. Poblacion VI, San Jose, Occidental Mindoro. Late quotations shall not be accepted.
