Bidding Documents may be purchased by interested bidders upon payment of non-refundable fee deposited to CASURECO IV account no. 3592100192 LBP Tigaon Branch. The copy of deposit slip must be sent to [casureco4\\_bactwg@yahoo.com](mailto:casureco4_bactwg@yahoo.com) at least one (1) hour before the start of the Pre-bid conference. The bid documents will then be sent in pdf format upon receipt of deposit slip.

Bid Documents are available for purchase on or before the Pre-bid conference only. However, if there are less than three (3) interested bidders for certain lots, the availability of bid documents will be extended until before the Opening of Bids. This is to ensure the competitiveness of the bidding.

All bids submitted must be accompanied by a bid security payable to CASURECO IV, in the amount equivalent to two percent (2%) of the amount of Approved Budget Cost (ABC). This bid security shall be valid for at least 150 days, starting from the date of the bid opening.
