- 3) Taxpayer's Identification Number





Important Notes:

1. Winning Bidder shall post Performance Bond equivalent to Five Percent (5%) of its bid within 5 working days after the receipt of Notice of Award.
2. The Winning Bidder shall make Full Payment in the form of Cash or Manager's Check, for the Bidded Non-Performing Assets within a period of Five (5) Days upon receipt of the Notice of Award.
3. The Performance Bond will be returned to the Winning Bidder after receipt of its Request letter and after the Bidder's Full Payment for the Bidded Non-Performing Assets.
4. The Bidded Non-Performing Assets will not be released, unless the Winning Bidder has made Full Payment for the Bidded Non-Performing Assets:
5. If the Winning Bidder has failed to release the Bidded Non-Performing Assets within a period of Ten (10) Working Days after full payment, the Management of NEECO II-Area 1 will Charge a Storage Fees equivalent to One Percent (1%) of the Total Bid Offer for every days of delay for a period one (1) month;
6. The Performance Bond will be Forfeited if the Winning Bidder Failed to comply on the above stipulations
