All bids must be accompanied by a Bid Security in a form of cash or manager's check equivalent to 2% of the ABC.

To qualify, interested bidders must submit electronic copy stamped with certified true copy in case of photocopied documents such as but not limited to: Company profile: Notarized statement in matrix form of all ongoing and completed government and private contracts (supported with purchase orders, job orders, etc.) including contracts awarded but not yet started, if any (for the last five years). Statement identifying the bidder's single largest completed contract similar to the contract to be bid within the relevant period as provided in the bidding documents with a value of at least 50% of the ABC (supported w/ contract, cert. of completion, project cost & cert. of acceptance), Copy of By-laws, Notarized statement of availability of key personnel and equipment, Notarized statement that prospective bidder is not blacklisted by any government or non-government agency; DTI Business Name registration or SEC registration certificate; Audited Financial Statements stamped received by the BIR for the immediately preceding year; Certificate of BIR Registration; Valid PICAB License Specialize in Electrical Works (Class C or D); Valid and current Mayor's Permit and Taxpayer's Identification Number.

All particulars relative to the bidding process shall be governed by the pertinent provisions of the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives - IRR-RA10531 (2017), Republic Act 9184 and On-line Public Bidding Guidelines as provided in the Government Procurement Policy Board (GPPB) Resolution No. 09-2020 dated May 7, 2020.

Submission and receipt of bids through electronic means are allowed as provided in the Government Policy Board (GPBB) Resolution No. 09-2020 dated May 7, 2020. However, personal submission and receipt of bids are also allowed.
