THE SUPPLIER willfully and faithfully delivers to LANECO the Supply and Delivery of Conductor Duplex Wire #6 use for Magna Carta, New Connection and replacement of defective and burned service drop wire chargeable to Reinvestment Fund for Sustainable Capex (RFSC) will be made within (30-45) days after receipt of the Notice to Proceed.
4. LANECO will hold a Pre-Bid Conference (date and time stated above) which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).
