(CASURECO I), through the 2022 General Appropriations Act (GAA) Sitio Electrification Program (SEP) Subsidy under the National Electrification Administration's (NEA) 2022 SEP Subsidy intends to apply the sum of Fourteen Million One Hundred Thirty One Thousand Six Hundred Ninety Eight Pesos and Forty Two Centavos (Php 14,131,698.42) being the Approved Budget for the Contract (ABC) to payments under the contract for Extension of Distribution Line for Sixteen (16) Sitios in the Municipalities of Libmanan, Pasacao, Ragay, San Fernando, Sipocot and Lupi, Camarines Sur.
