**INVITATION FOR NEGOTIATED PROCUREMENT**

1. In view of the two (2) failed competitive biddings, the Quezon II Electric Cooperative, Inc., through its Bids and Awards Committee (BAC), invites interested bidders to participate in the negotiated procurement for the project: **SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 7.62 KV TIE LINE (OVERHEAD) AND DISTRIBUTION LINE EXTENSION, INSTALLATION OF KILOWATT HOUR METERS, DUPLEX SERVICE DROP WIRES AND HOUSEWIRING MATERIALS FOR THREE HUNDRED (300) POTENTIAL CONSUMERS IN PUROK I, II, III, IV & V, SITIO KATAKIAN, BRGY. BUSDAK, PATNANUNGAN, QUEZON** with an Approved Budget for the Contract (ABC) of Php. 20,547,153.68, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulation of the Republic Act No. 9184, otherwise known as the "Government Procurement Act";
2. The Target Date of Completion is within One Hundred Fifty (150) calendar days upon receipt of the Notice to Proceed. Bidders should have all their ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; single largest completed contract similar to the contract to be bid, within the last three (3) years prior to the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly the Instruction to Bidders;
3. **QUEZELCO II will hold a Negotiation Conference on October 17, 2022 (Monday), 2:00 P.M. at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon.**
4. Only those bidders who have submitted their respective **Letter of Intent to Participate** will be allowed in the Negotiation Conference to be held virtually or on Face to Face
5. All proposal shall contain Eligibility and Technical as well as Financial Documents as particularly prescribed in the Bid Document Checklist;
6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights and privileges to Filipino citizens, pursuant to RA 5183;
7. A complete set of the Negotiated Procurement Documents may be acquired by interested bidders on October 11, 2022 (Thursday) from 9:00 AM to 4: 30 PM upon payment of a non-refundable fee in the amount of Twenty Five Thousand Pesos (Php. 25, 000.00).

It may also be downloaded free of charge from QUEZELCO II website, provided that bidder/s who is/are interested to participate shall pay the applicable non-refundable fee on or before the scheduled Negotiation Conference on October 17, 2022.

Interested bidders who have previously purchased the bidding documents will no longer pay, instead, they must submit Letter of Intent to Participate in the Negotiated Procurement and submit new set of proposals/documents during the submission of bids.


8. Proposal in excess of the Approved Budget for the Contract shall be automatically rejected.
9. Proposal must be duly received by the BAC Secretariat at the address below on or before October 31, 2022 (Monday) at 2:00 PM at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon. All proposal must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB. Late bids shall not be accepted;
10. The opening of proposal shall be held on October 31, 2022 (Monday) at exactly 2:00 PM at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon. Proposal shall be opened in the presence of the bidders' authorized representatives who choose to attend at the address below;
11. QUEZELCO II reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders;
12. QUEZELCO II assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
