In view of the implementation of government restrictions on transport and travel by reason of Covid-19 Pandemic, SORECO I will conduct an online bidding through video conferencing. Online or electronic submission and receipt of bids for procurement modalities where a two-envelope procedure or sealed price quotation with password protection is required to ensure the security, integrity and confidentiality of the bids submitted. Access to a password-protected Bidding Documents shall only be on the opening date and time. The passwords for accessing the file will be disclosed by the Bidders only during the actual bid opening which may be done face-to face through video-conferencing, webcasting or similar technology.

Bids containing the financial and technical proposals/offers, in separate envelope duly labelled as such, will be received by the BAC on the above-mentioned schedule thru online or electronic facilities. The proposal of bidders found eligible will be opened and evaluated on the same date and time in the presence of the Bidders or Bidder's representatives. However, simultaneous submission of hard copies of bids is still required by the BAC since the same shall be examined during post-qualification to determine the authenticity of documents submitted online

Interested eligible bidders must send their accreditation requirements to this Email Add: soreco1bac@gmail.com. Accreditation fee shall be collected from interested Bidders in the amount of One Thousand Five Hundred (Php1,500.00) pesos only. Payment for accreditation fees, bid documents and bid security shall be deposited to SORECO I Landbank account no. 2601-0342-23. The copy of deposit slip must be sent in PDF form thru email to BAC secretariat. Those who purchased Bid Document/s can attend the Pre-Bid Video-Conference and join the online bidding. Send samples of materials before bid opening conference. Failure to send samples is a ground for disqualification.

Delivery of all electrical materials shall be thirty (30) calendar days upon receipt of Notice of Award and Notice to Proceed.
