Invitation to Bid for the energization of five (5) Sitios in the province of Siquijor under the Sitio Electrification Program (SEP) funded by 2022 SEP GAA Subsidy

The PROVINCE OF SIQUIJOR ELECTRIC COOPERATIVE, INC. through the Sitio Electrification Program (SEP) intends to apply the sum of PHP 5,920,631.06 being the Approved Budget of the Contract (ABC) to payments under the contract for the electrification of five (5) sitios namely, Upper Banahaw and Cabukalan in Capalasanan, Lazi; Lawiswis Kawayan in Kinamandagan, Lazi; Ubos in Bonga, Maria and Lubhak in Cang-asa, Siquijor. Lazi. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The PROSIELCO, through its Bids and Awards Committee (BAC) now invites bids for the SUPPLY AND DELIVERY OF MATERIALS, CONSTRUCTION OF LINE and HOUSEWIRING INSTALLATION FOR THE IMPLEMENTATION OF SITIO ELECTRIFICATION PROGRAM (SEP) FOR THE YEAR 2022. Delivery of goods and services is required within a period of three hundred twenty (320) days after the awarding of contract/ issuance of the Notice to Proceed to the winning bidder. A complete set of Bidding Documents may be purchased by interested Bidders on *November 7, 2022* from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Php 10,000.00*.

It may also be downloaded free of charge from the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than *November 27, 2022 (before 2:00 PM)*.

The PROSIELCO will hold a **Pre-Bid Conference** on **November 15, 2022 at 2:00 'clock in the afternoon** at *PROSIELCO Solidarity Hall, PROSIELCO Office, Nonoc, Larena, Siquijor* which shall be open only to all interested parties who have purchased the Bidding Documents

Bids must be delivered to the address below on or before **November 27, 2022 (until 12:00 o'clock noon)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.1**.
