Invitation to Apply for Eligibility and to Bid for the
“Supply & Delivery of Materials for the Construction of Distribution Line for SEP 2022-16 Sitios”

1. The Tablas Island Electric Cooperative, Inc. through Bids and Awards Committee (BAC) invites interested parties to a sealed bidding for the supply and delivery of electrical materials needed for the Construction of Distribution Lines under Sitio Electrification Program (SEP) 2022, funded by 2022 SEP GAA Subsidy from the National Electrification Administration (NEA).

Being the Approved Budget of the aforesaid item. Bids received in excess of the ABC for the said lot shall be automatically rejected at the bid opening.

2. TIELCO now invites bids for the **Supply and Delivery of Materials for the Construction of Distribution Line for SEP 2022-16 Stios**. Delivery of the goods is required within thirty (30) calendar days from receipt of the Notice to Proceed (NTP) and Purchase Order (PO) and shall be delivered to TIELCO Main Office, Dapawan, Odiongan, Romblon. The description of the eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act” and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from TIELCO Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below or via BAC official email address tielco_pbac@yahoo.com during **Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays**.

5. A complete set of Bidding Documents may be acquired by interested bidders from November 8 (office hours 8:00 AM to 5:00 PM) until November 15, 2022 at 12:00 NN, Philippine Standard Time from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of Twenty Five Thousand pesos (PHP 25,000.00).

Due to travel restrictions, Bidders may also acquire the electronic copy of the complete set of the Bidding Documents via official email address of BAC tielco_pbac@yahoo.com, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the deadline of submission of bids.

6. TIELCO will hold a Pre-Bid Conference on November 15, 2022 at 1:30 PM, Philippine Standard Time at the TIELCO Main Office, Dapawan, Odiongan, Romblon, which shall be open to prospective bidders.

A pre-bid conference shall be held at the venue and on the date and time indicated in the Invitation to Bid via virtual/video conferencing to clarify and address the Bidders' questions on the pertinent technical and financial components.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring entity's requirement. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/ Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before November 25, 2022, at 9:30 AM, Philippine Standard Time. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 17.

Bid Opening shall be on November 25, 2022 at 9:30 AM, Philippine Standard Time at TIELCO Main Office, Dapawan, Odiongan, Romblon. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

8. TIELCO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


