Bid Validity shall not exceed one hundred twenty (120) calendar days from the date of the opening of bids.

Bid Security is preferably in the form of Cash, Cashier's Cheque or Manager's Cheque amounting to at least two percent (2%) of the ABC.

Performance Security is preferably in the form of Cash, Cashier's Cheque or Manager's Cheque amounting to at least ten percent (10%) of the Contract Price.

Bid documents will be available only to prospective bidders upon payment of a non-refundable amount per category as indicated above. Prospective bidders may attend the pre-bidding conference for the orientation and clarification of the procurement guidelines.

Due to ongoing COVID-19 Pandemic, the Pre-bid conference, bidding proper and opening of bids shall be done through virtual conferencing. Bidder who failed to attend the pre-bid Conference, as scheduled can still participate during the bidding proper.
