Failure to comply the abovementioned will automatically mean disqualification. Only those who paid the participation fee PER LOT in the amount specified above shall have their bid offers opened. Bid offers received in excess of the ABC shall be automatically rejected.

Bidders will be advised to log in and join the BAC meeting room on which the link shall be provided to the prospective bidders before the start of the meeting.
