## **INVITATION TO BID FOR TARELCO I 69KV POLE RELOCATION PROJECT (DOABLE)**

TARELCO I invite eligible bidders to bid for TARELCO I 69KV Pole Relocation Project (Doable). **Bidders are required to bid for the whole lot.** Philippine Contractors Accreditation Board (PCAB) License must be **SMALL B LICENSE CATEGORY C & D Electrical Works.**

**Approved Budget for the Contract (ABC) is Twenty-Three Million Seven Hundred Ninety-Nine Thousand and Four Hundred Fifty-Eight Pesos (₱ 23, 799, 458.00).**

The project shall be funded by the **Department of Public Works and Highways (DPWH)**. Quoted price must be inclusive of VAT. The project must be completed within Two Hundred Ten (210) calendar days commencing upon receipt of the Notice to Proceed.

Potential bidders must process their accreditation and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process. The accreditation requirements shall be provided by the BAC Secretariat. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to Twenty-Five Thousand Pesos (₱ 25, 000.00) for the cost of bidding documents.

All fees must be deposited to the BAC's bank account to be provided by the Secretariat. A scanned copy of the deposit slip must be emailed to the Secretariat, once the payment was confirmed, an electronic copy of the bidding documents and official receipt shall be emailed to the prospective bidder.

A complete set of bidding documents may be purchased starting **December 11, 2022 until 4:00 P.M. of December 17, 2022** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference through a videoconferencing using zoom app shall be held on **December 19, 2022 2:00P.M.** at the TARELCO I Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **December 18, 2022. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.**

Bidders shall send their sealed proposals via courier and must be received by the BAC on or before **January 2, 2023**, proof of shipping must be submitted to the Secretariat as evidence. Bid Opening shall be live streamed via zoom app on **January 3, 2023 2:00P.M.** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

The meeting ID and password shall be sent to all bidders' email address three (3) days before the schedule of pre-bid conference and bid opening. Only one (1) access per company shall be allowed.

Bidding shall be conducted through a public bidding procedures using non-discretionary "pass/fail" criterion as specified in Republic Act 9184 and its IRR.

All bids submitted must be accompanied by a Bid Security in an amount of not less than two percent (2%) of the ABC. For further information, please contact **VICTOR FLOREM B.
