The Pre-Bid Conference will be conducted online through zoom software application. Invite link will be sent by the BAC Secretariat thru email together with the bid documents. Only those who have bought the bid documents are allowed to attend. Only one (1) account is allowed per bidder. Attendance to the Pre-bid Conference is mandatory.

Electronic copy of bids must be received by the BAC Secretariat thru email prior to the date and time of Bid Opening indicated above, at which date and time the eligibility requirements, technical and financial proposals will be opened and read in the presence of bidders or their authorized representatives.

Sealed bids (hard copies) must be sent at least one (1) day before the bid opening date and the official receipt of the courier must be submitted thru email of the BAC Secretariat before the online opening of bids.

The Online Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in The 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the government procurement reform act.

BILECO through the BILECO BAC reserves the right to reject any or all bids, declare failure of bidding, to waive any minor defects or informalities therein and to accept any or all offers as may be considered most responsive and advantageous to the procuring entity. It assumes no obligation whatsoever for any expenses or loss that may be incurred by the bidder in the preparation of bids, nor does it guarantee that an award will be made.
