The Approved Budget for the Contract (ABC) is Six Million Nine Hundred Twenty Thousand Pesos (₱ 6, 920, 000.00) or Twenty Thousand Pesos (₱ 20, 000.00) per Employee and Board of Directors. **Source of fund for the said request shall come from the General Fund. Quoted price must be inclusive of VAT.**

**The healthcare services shall be for a period of one (1) year commencing upon receipt of the Notice to Proceed.**

Potential bidders must apply for accreditation and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process. The accreditation requirements shall be provided by the BAC Secretariat. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee for the cost of bidding documents.

All fees must be deposited to the BAC's bank account to be provided by the Secretariat. A scanned copy of the deposit slip must be emailed to the Secretariat, once the payment was confirmed, an electronic copy of the bidding documents and official receipt shall be emailed to the prospective bidder.

A complete set of bidding documents may be purchased starting **January 12, 2023 until 4:00 P.M. of January 18, 2023** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference through a videoconferencing using zoom app shall be held on **January 20, 2023 2:00P.M.** at the TARELCO I Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **January 19, 2023. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.**

Bidders shall send their sealed proposals via courier and must be received by the BAC on or before **February 2, 2023**, proof of shipping must be submitted to the Secretariat as evidence. Bid Opening shall be live streamed via zoom app on **February 3, 2023 2:00P.M.** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

The meeting ID and password shall be sent to all bidders' email address three (3) days before the schedule of pre-bid conference and bid opening. Only one (1) access per company shall be allowed.

Bidding shall be conducted through a public bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017).
