The submitted documents of each bidder shall be examined and checked for completeness against a checklist to ascertain that they are all present using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager’s check and submitted together with their Bids. The presence of the bidder during the Pre-bid Conference is optional. The prospective bidder must have completed within 5 years from the date of bid opening a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, and must be at least fifty percent (50%) of the ABC.
