



INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF HOUSEWIRING MATERIALS FOR EXTENSION OF DISTRIBUTION LINES FOR SIXTEEN (16) SITIOS SEP 2022

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I), through the **2022 General Appropriations Act (GAA) Sitio Electrification Program (SEP) Subsidy under the National Electrification Administration (NEA) 2022 SEP Subsidy** intends to apply the total sum of **One Million Seven Hundred Sixty Thousand Five Hundred Fifty pesos (Php. 1,760,550.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **The Supply and Delivery of Housewiring Materials for Extension of Distribution Lines for Sixteen (16) Sitios Under SEP 2022/CAS1-2022HWM**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. CASURECO I now invites bids for **The Supply and Delivery of Housewiring Materials for Extension of Distribution Lines for Sixteen (16) Sitios Under SEP 2022/CAS1-2022HWM**.
3. Delivery of the Goods is required with in **Sixty (60) Calendar Days upon receipt of Notice to Proceed**. Bidders should have completed within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. Interested bidders may obtain further information from **CASURECO I** and inspect the Bidding Documents at the address given below from **February 9, 2023 to February 27, 2023 from Monday to Friday during office hours 8:00 a.m. to 5:00 p.m. (except Saturdays, Sundays and Holidays)**, and on **February 28, 2023 from 9:00a.m. to 12:00p.m.**
