The Aklan Electric Cooperative, Inc. (AKELCO) invites all interested bidders to submit bid for the following projects, to wit:

1. Approved Budget for the Contract (ABC):

- a. Project 1 is inclusive of materials cost, mobilization and demobilization cost, labor cost and contingency, overhead cost and 12%VAT;
- b. Project 2 is inclusive of 12% VAT and Agency Fee;
- c. Projects 3, 4, 5 and 6 is inclusive of freight, handling and 12% VAT.

2. Source of Fund:

- a. Projects 1, 2 and 4 is EC’s Distribution, Supply and Metering (DSM) Fund;
- b. Projects 3 is Government Subsidy; and
- c. Project 5 and 6 is EC’s Reinvestment Fund for Sustainable Capital Expenditures (RFSC).

3. Delivery Schedule:

- a. Project 1: the duration of the project shall be within ninety (90) calendar days upon receipt of Notice to Proceed;



- b. Project 2: the duration of the contract is One (1) year from the signing of contract;
- c. Project 3: within sixty (60) calendar days from the Issuance of Notice to Proceed; and
- d. Projects 4, 5 and 6: within thirty (30) calendar days from the issuance of Notice to Proceed and the item shall be delivered at AKELCO Warehouse, AKELCO Main Office, Mayor Saturnino G. Fernandez Compound, Poblacion, Lezo, Aklan.

The bidding will be conducted through competitive bidding procedures using the non-discretionary "Pass/Fail" criterion as provided for in the IRR of RA 10531 for Projects 1, 2, 4, 5 and 6 and RA 9184 for Project 3.
