

- Interested Bidders must submit their Letter of Intent thru the BAC official email address stated herein where all transactions pertaining to the bidding shall be communicated.
- Bidding Documents issuance shall be thru email address of the bidders who have paid the cost of the Bid Documents which is non-refundable.
- Pre-Bid Conference will be held face to face at the NORSAMELCO Main Office, Brgy. Magsaysay, Bobon, Northern Samar. Only those who have bought the bid documents are allowed to attend.
- The eligibility requirements, technical and financial proposals will be opened in the presence of bidders or their authorized representatives. Late bids shall not be accepted.
- NORSAMELCO reserves the right to reject any or all bids, declare failure of bidding, to waive any minor defects or informalities therein and to accept any or all offers as may be considered most responsive and advantageous to the procuring entity.
