Prospective bidders must first send a Letter of Intent to SURSECO-I and shall secure an Accreditation from the Cooperative's Bids and Awards Committee (BAC). Interested bidders may obtain the list of Documentary Requirements for Eligibility and Bidding Forms upon payment of the Accreditation Fee (PhP 1,000.00) and the non-refundable Bidding Documents Fee per lot through overthe-counter payment at the SURSECO-I Main Office Teller.

The Bid must be accompanied by a BIDDER'S BOND in the form of CASH or MANAGER'S CHECK in the amount equal to <u>2% of the ABC</u>. No other form of bid bond will be accepted. The bidder's bond is to be enclosed in the sealed envelope containing the bid. All prospective bidders must be **VAT-registered**.

Attendance at the Pre-Bidding Conference is optional. However, matters discussed and agreed upon by the attending parties are final and irrevocable. All bids and other documents shall be submitted in a sealed envelope, properly labeled and addressed to the Chairperson, Bids & Awards Committee, SURSECO-I, and shall be submitted on or before the Opening of Bids. All bids, together with the required eligibility documents, shall only be opened during the Opening of Bids. Both the Pre-Bidding Conference and the Opening of Bids shall be held at the SURSECO-I Main Office at San Fernando, Bislig City, Surigao del Sur.

Consistent with its own Procurement Guidelines/Policies and NEA issuances, SURSECO-I reserves the right to reject any and all bids, declare a failure of bidding, or not award a contract for justifiable grounds.
