- Bids must be duly received by the BAC Secretariat through submission of hard copy on or before April 24, 2023 at 8:30 AM. Late bids shall not be accepted.
- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
- Bid opening shall be on April 24, 2023 at 9:00 AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
