OMECO now invites Accredited Suppliers and not for the Sealed Canvass for the Supply and Delivery of Hardware and Materials for the Replacement / Uprating of Underbuilt Conductors at SAMARICA Areas is required within Thirty (30) Calendar Days from receipt of Notice to Proceed (NTP) and Purchase Order (PO).
- 3. Bidding will be conducted through Sealed Canvass using a non-discretionary "pass/fail" criterion. Bidding is open to all OMECO's Accredited and Non-Accredited Suppliers, provided that Non-Accredited Suppliers must submit required accreditation documents listed in the Accreditation Check List Requirement and Accreditation Fee amounting to Three Thousand Pesos Only (Php 3,000.00) as provided.
- 4. Request for Quotation (Sealed Canvass) is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
