1. The **Occidental Mindoro Electric Cooperative, Inc., (OMECO)** through its Bids and Awards Committee (BAC), invites prospective bidders to apply for eligibility and subsequently bid for the Supply and Delivery of Hardware and Materials needed:

2. Delivery of the Goods is required within **thirty (30) calendar days** from receipt of the Notice to Proceed (NTP) and Purchase Order (PO), and shall be delivered to OMECO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro. The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

5. Interested bidders may obtain further information from OMECO – Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below or via BAC official email address omeco2018bac@gmail.com during **Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays.**

6. Attendees to the Pre-Bid conference are only the prospective bidders who have bought bid documents, or their authorized representative (duly notarized).

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin. The BAC will also conduct the pre-bid conference via virtual conference using ZOOM application.

OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR - RA 10531 (2017), without thereby incurring any liability to the affected bidder or bidders.
