INVITATION TO BID Simplified Bidding No. 04 Series of 2023

Pursuant to National Electrification Administration (NEA) Memorandum No. 2017-019, otherwise known as the "Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)," the Isabela-I Electric Cooperative, Inc. (ISELCO-I), through its duly constituted Bids and Awards Committee (BAC), now invites interested bidders to participate and submit bid proposals relative to the procurement and installation of **69KV Disconnecting Switch (Pole Type)** to be used by the Cooperative for its 20 MVA Ramon Substation Isolation Equipment.

- 3. Bid proposals must be VAT inclusive, and the same must be submitted personally or via courier to the BAC Secretariat at the address given below on or before 24 April 2023 until 5:00 PM. Bid proposals must be placed in a sealed envelope. Late bids shall not be accepted.
