Copy of deposit slip must be sent to bac.alecoinc@gmail.com at least one (1) hour before the start of the pre-bid conference. The bid documents will then be sent upon receipt of the deposit slip.
- Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.
- All bids submitted must be accompanied by a bid security payable to ALECO in the amount equivalent to two percent (2%) of the Approved Budget of the Contract (ABC). This bid security shall be valid for at least 120 days from the date of the bid opening.
- ALECO will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at **ALECO Board Room, W. Vinzon Street, Albay District, Legazpi City** which will be opened to all interested parties who qualify and who have purchased bidding documents.
