Bidding documents shall be provided upon payment of non-refundable Bidding Documents fee stated above. Only those who have purchased the Bidding Documents until 12NN of the day before the pre-bidding conference shall esent invitation to participate in the pre-bidding conference and raise or submit written queries or califications. However, bidding documents shall still be available for purchase after the pre-bidding conference. Deadline for purchase of bidding documents is 5 days before the bid coening data.

Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the NEA Memorandum No. 2017-019: Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives, IRR - RA 10531 (2017).

Prospective bidders are required to have a stable internet connection during the conferences and the BAC shall not be liable for any unexpected disruption due to poorfunstable signal which may cause prospective bidders' inability to catch up with the conference. All Bid Proposals shall be accepted at the BAC Office two (2) hours before the scheduled bid opening conferences, otherwise, shall be disqualified.
