3. Taxpayer's identification number;
4. BIR Value Added Tax registration;
5. A certificate that the supplier/contractor is not blacklisted or banned from bidding by the government or any of its agencies and private corporations or electric cooperatives;
6. Compliance with EO #398:
 - a. Proof of VAT payment for the past six months; and
 - b. Tax clearance from BIR for the last two quarters.
7. On-going, completed, or awarded contract not yet started within the relevant period specifying the following:
 - a. Name of the contract;
 - b. Date of the contract;
 - c. Amount of contract and value of outstanding contracts;
 - d. Date of Delivery; and
 - e. End-user’s acceptance if completed.

Please be advised, however, that a Non-refundable Accreditation Fee of Two Thousand Five Hundred Pesos (Php2,500.00) is valid for one (1) year. Likewise, accredited bidders shall secure the bidding documents before the pre-bid conference.
