Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.




Bidding documents are available in electronic copy and will be posted in Coop's official website: www.neeco2area1.com to be downloaded by the bidders.
