For Category III General Fund

Delivery Period:

For Category I: Completion of Projects within seventy-five (75) calendar days upon receipt of Notice to Proceed/Approved Contract either personally or sent by registered mail or electronic mail.
For Category II and III: Thirty (30) calendar days upon receipt of Purchase Order.

All Eligibility Statement and Screening, Bid Security, Performance Security, Warranty Security, Pre-bidding Conference(s), Evaluation of Bids, Post Qualification, Award of Contract and other particulars relative to the bidding shall be governed by the pertinent provisions of RIRR of R.A. 9184.

Bid Validity shall not exceed one hundred twenty (120) calendar days from the date of the opening of bids.

Bid Security is preferably in the form of Cash, Cashier's Cheque or Manager's Cheque amounting to at least two percent (2%) of the ABC.

Performance Security is preferably in the form of Cash, Cashier's Cheque or Manager's Cheque amounting to at least ten percent (10%) of the Contract Price.

Warranty Security is preferably in the form of Cash, Cashier's Cheque or Manager's Cheque amounting to at least five percent (5%) of the Contract Price.

Warranties: One (1) year warranty for structural defects after issuance of Certificate of Inspection and Final Acceptance duly approved by the General Manager for the Construction of SEP 2023 and one (1) warranty after the full delivery for the house wiring materials, service drop wire and kWh meter.

Bid documents will be available only to prospective bidders upon payment of a non-refundable amount per category as indicated above. Prospective bidders may attend the pre-bidding conference for the orientation and clarification of the procurement guidelines.

Due to ongoing COVID-19 Pandemic, the Pre-bid conference, bidding proper and opening of bids shall be done through virtual conferencing. Bidder who failed to attend the pre-bid Conference, as scheduled can still participate during the bidding proper. However, it will mean a waiver of their right to question any provision of the bidding.

MOELCI-II assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
