INVITATION TO BID

The Romblon Electric Cooperative, Inc. (ROMELCO) thru its Pre-qualification Bids and Awards Committee (PBAC) invites accredited/eligible electrical contractors to submit bid for the Supply of Labor and Materials for the Construction of Distribution Lines and Household Connections for Thirty Two (32) sitios particularly in the island Municipalities under ROMELCO's coverage area. The said project will be funded from the proceeds of Subsidy Fund Releases from the National Electrification Administration (NEA) for Sitio Electrification Program (SEP) with the following Approved Budget:

The bidders should possess an extensive and successful experience of at least five (5) years in the construction of distribution lines in remote and isolated grids in the coverage area of the electric cooperatives.

The winning bidders shall complete the said projects within 180 days for Schedule I and II upon awarding of the contract.

All bid documents must be submitted addressed to the CHAIRPERSON, ROMELCO PBAC, Capaclan, Romblon, Romblon. Bidders may choose to submit personally thru its authorized representatives or send their Qualification and Bid Documents thru courier. Opening of Bids shall be done at ROMELCO Main Office, at Brgy. Capaclan, Romblon, Romblon during the scheduled time and date. The bidders may opt to attend personally or send representative authorize during the Opening of Bids.
