The delivery of materials shall be completed within thirty (30) calendar days from the Issuance of Notice to Proceed (NTP) and conformance of the Purchase Order (PO) and shall be delivered at AKELCO Warehouse, AKELCO Main Office, Mayor Saturnino G. Fernandez Compound, Poblacion, Lezo, Aklan.
