

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID BID NO. 2023-04 & 2023-05

CEBU III ELECTRIC COOPERATIVE, INC. (**CEBECO III**), through its **Bids and Awards Committee** (**BAC**), hereby invites all interested manufacturers, suppliers, dealers, authorized franchised dealers, and contractors who are clothed with a valid PCAB License with specialty in electrical works to submit their respective bids for the Supply of Labor and Materials for the implementation of Sitio Electrification Program funded under the 2022 & 2023 General Appropriations Act as approved by the National Electrification Administration as described hereunder:

- 1. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- 2. A Single-Stage: Two-Envelope Bidding Procedure is to be used to evaluate the technical responsiveness and the Bidder's qualifications before opening the price proposal.
- 3. The prospective bidder must have completed within five (5) years prior to the bid opening a Single Largest Completed Contract (SLCC) that is similar to Construction of the Distribution Line and Installation of kWh Meters, Duplex Service Drop Wires and Housewiring Materials, and whose value, adjusted to current prices using the National Electrification Administration Price Index, must be at least fifty percent (50%) of the ABC.
- 4. The presence of the bidder during the Pre-bid Conference is optional.

- 5. A complete set of bidding documents may be secured from the BAC Secretariat upon payment of a non-refundable bidding fee. A soft copy of the bidding documents will be provided via e-mail.
- 6. During the signing of contracts, Terms of payments shall be in this mode: 15% of the contract amount representing the down payment for the mobilization, 35% representing the 50% completion of the project in its 1st progress billing, 40% representing 100% completion of the project in its 2nd progress billing, and the remaining 10% of the contract amount is upon Testing and Commissioning of the completed project.
- 7. In relation to the progress billing, progress payments are subjected to the retention of 10% based on the total amount in each identified progress billing and determined by the procuring entity.
- 8. Bids received in excess of the ABC shall automatically be rejected at bid opening.
