The Bidding Documents (BD) shall be purchased from Peninsula Electric Cooperative, Inc. (PENELCO) Main Office, Roman Superhighway, Balanga City 2100, Bataan, upon notification and upon payment of non-refundable fee for corresponding schedule/s in cash beginning **September 27, 2023 (Wednesday)**.

Pre-bid conference shall be conducted at the PENELCO Main Office at 10:00AM (official time) on **October 11, 2023 (Wednesday)**.

Sealed proposal shall be received by the PENELCO-PBAC at PENELCO Main on or before 10:00AM (official time), **October 25, 2023**, at which time and place said proposal shall be opened and read in the presence of Bidders or Bidders' representatives who choose to attend. Late submission shall not be accepted.

All bids submitted must be accompanied by a **bid security of not less than five (5%) percent of the total bid price** in a form of cash, cashier's check, manager's check, bank guarantee or any other form required by **Government Procurement Reform Act**.

The PENELCO hereby reserves the right to reject any or all bids, to waive any informalities therein and to accept such bid as may be considered advantageous to the cooperative.
