Once payment is verified, the bid documents will be emailed to the interested bidders. Only those who have purchased the bid documents are qualified to participate in the bidding.

The bidding activities will be conducted on the above schedules and venue. Any bidder who cannot be physically present can attend through video conferencing via Zoom or any video conferencing application which will be hosted by the Bids and Awards Committee Team 3. A video conferencing meeting ID number will be provided to the bidders.

The bidding documents may be submitted through electronic mail or facsimile subject to the submission of the printed copies, provided that the online submission of bids thru email is received on or before the scheduled date and time of the Opening of Bids and that the bidder must send the actual bid documents thru courier services, the tracking receipt should also be sent as an attachment to the email or a separate email on or before the scheduled date and time of Opening of Bids.

The Bids and Awards Committee will conduct a COMPETITIVE BIDDING using a non-discretionary “pass/fail” criterion as specified in NEA Memorandum 2017-019 otherwise known as “Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives.” NORECO II reserves the right to reject any bid and all proposals, to declare failure of bidding, and to reject all bids prior to the awarding of contract without incurring any obligations to any bidder or bidders in the preparation and tender of their bids.
