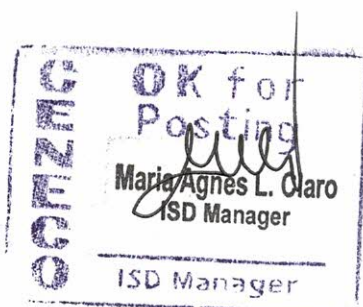
All items/bids shall be subjected to examination, evaluation and post qualification using the criteria set by the Implementing Rules and Regulations of Republic Act 10531.
