Quoted price must be inclusive of VAT. The delivery of the units must be completed within thirty (30) calendar days commencing upon receipt of Purchase Order and Notice to Proceed.

Potential bidders must apply for accreditation and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process. The accreditation requirements shall be provided by the BAC Secretariat. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to Ten Thousand Pesos (₱ 10, 000.00) for the cost of bidding documents.

A complete set of bidding documents may be purchased starting 01 October 2023 until 12:00 P.M. of 07 October 2023 by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference shall be held on 09 October 2023 10:00A.M. at the TARELCO I Main Office Board Room. Questions and clarifications regarding the bid documents must be submitted on or before 08 October 2023. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.

The Bid Opening shall be held on 23 October 2023 10:00A.M. in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

Bidding shall be conducted through a public bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017).
