

COLLECTION at DISCONNECTION Policy

Ang Collection at Disconnection Policy ay mahigpit na ipinatutupad ng Quezelco 1 para sa mga delingkwenteng kasapi/tagatangkilik/kamay-ari ng kooperatiba. Kung hindi nabayaran ang bill matapos ang due date ay maaari nang maputulan ng serbisyo ng kuryente makalipas ang 48 oras. 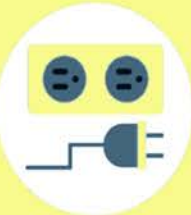

ANTI-OBSTRUCTION OF POWER LINES ACT (REPUBLIC ACT 11361)

"AN ACT ENSURING THE CONTINUOUS AND UNINTERRUPTED TRANSMISSION AND DISTRIBUTION OF ELECTRICITY AND THE PROTECTION OF THE INTEGRITY AND RELIABILITY OF POWER LINES, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF"

signed by President Rodrigo R. Duterte on 08 August 2019

THE FOLLOWING ACTS ARE PROHIBITED WITHIN THE POWER LINE CORRIDOR (PLC):



- Planting tall trees or vegetation
- Conducting any hazardous activities



- Refusing or preventing duly authorized agents of Power Line Owner/Operator entry to the property
- Constructing any hazardous improvements

PENALTIES FOR VIOLATING THE LAW:

1st OFFENSE	2nd OFFENSE	3rd OFFENSE
Up to 6 months imprisonment, P 50,000 fine, or both	Up to 6 years imprisonment, P 100,000 fine, or both	Up to 12 years imprisonment, P 200,000 fine, or both

ASSISTANCE FROM THE LGU

The LGU may render the following, among others:

- Inform and educate their respective constituents about the policies stated herein and the implementation of this Act and its IRRs;
- Issue ordinances to prevent obstructions and hazardous activities within the Power Line Corridors in their respective localities; and
- Provide all other means to assist the PLO to properly and safely perform their duties and mandates under this Act and its IRR, as the LGU may deem necessary.

ASSISTANCE FROM THE PNP & AFP

In the performance of the activities under Sections 7 & 8 of the Act, the Power Line Owner/Operator may seek the assistance of the relevant AFP and PNP units which has territorial jurisdiction over the area of concern. The AFP and/or PNP shall render such assistance, as it may deem necessary.

Either the AFP or the PNP is prescribed to act in contradiction to the law enforcement entity who shall assist the Power Line Owner/Operator in the conduct of the activities under Sections 7 and 8 of the Act.

RIGHTS OF THE POWER LINE OWNER/OPERATOR INSIDE THE POWER LINE CORRIDOR

Pursuant to Section 7 of the Act, the Power Line Owner/Operator shall have the right to enter the said property in order to prevent and remove any power line obstruction within the Power Line Corridor, whether located on a public property, private property or on its own property.

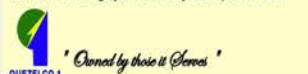
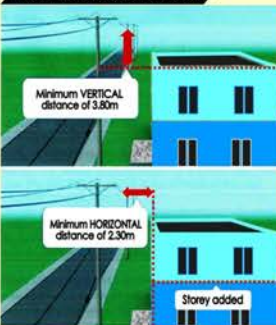
REQUIRED SAFETY CLEARANCES FOR OVERHEAD LINES

A. FOR VEGETATION



The Power Line Corridor (PLC) is bounded by points ABCDE and F. From points C to D, There shall be NO tall growing plants such as vines, and other plant species, which grow or have the potential to grow more than three (3) meters in height in the ground. The space bounded by points A, B, E and F, shall always be clear of any part of vegetations. Points A and F shall be extended as reference in pruning the farthest tall growing plants that will affect the integrity and reliability of the power lines.

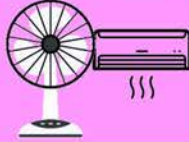

Ang "flying connection/illegal connection" ay karaniwang sanhi ng sunog at disgrasya. Upang mapangalagaan ang inyong bahay at ari-arian, huwag makikabit sa kapit-bahay. Kumuha ng kaukulang papeles sa lokal na pamahalaan upang magkaroon ng sariling linya ng kuryente.

Iligal na Koneksyon

Huwag hawakan ang mga gamit na de-kuryente, mga saksakan o switch kung basa ang kamay. Iwasang gumamit ng extension cord sa mga basang lugar tulad ng banyo o kusina.

Kung ikaw ay kinatawan lamang ng tunay na may-ari dahil hindi sya personal na makakapag-asikaso dahil nagtatrabaho sa ibang lugar o bansa, kinakailangang magdala ng notaryadong Special Power of Attorney (SPA) bilang katibayan ng awtorisasyon sa pagganap ng mga transaksyon na kailangan sa QUEZELCO I kasama ang kanyang pinakabagong litrato (1x1 ang sukat) at isang valid ID.

2. Pumunta sa tanggapan ng QUEZELCO I sa inyong lugar para sa Pre-Electric Service Connection Seminar (PESCS) sa nakatakdang araw at oras ng seminar. Para sa schedule ng PESCS, makipag-ugnayan lamang sa ating sangay-tanggapan o tingnan sa official facebook ng QUEZELCO I. (QUEZELCO I-New Page)

Kung hindi kayo makakaalis sa inyong tahanan ay maari ring mag-log-in sa aming website sa www.quezelco1.com, i-click ang Consumer Services at hanapin ang e-PESCS.

3. Kumuha ng mga papeles sa inyong lokal na pamahalaan (LGU) tulad ng mga sumusunod:

- Zoning Clearance
- Electrical Permit
- Fire Safety Inspection Certificate
- Certificate of Final Electrical Inspection (CFEI)

4. Matapos kumuha ng papeles sa munisipyo ay isumite naman ang mga sumusunod sa QUEZELCO I:

the DAYS OF 12 HOLIDAY SAFETY

- LIGHTS OUT!**
Always turn off holiday lights when you leave the house unattended or when going to bed. The lights could short out and cause a fire.
- Merry & BRIGHT**
Carefully inspect holiday light strings each year and throw away any with frayed cords, cracked lamp holders or loose connections. When replacing bulbs, unplug the light string and be sure to match voltage and wattage to the original bulb.
- Planes, Trains & AUTOMOBILES**
Extended vacations are common during the holiday season and criminals keep their eyes open for empty homes. Ask a friend or neighbor to pick up the mail, leave a few indoor lights on and do not leave a spare key in an easy to find place. Never discuss your vacation plans with strangers or post it on social media sites.
- TREE TOPPERS**
Place ornaments higher on the tree than children or pets can reach. If swallowed, ornaments or pieces of them can cause blockages or other serious injuries. The hooks that many ornaments use are detachable and pose a choking hazard.
- CAUTIOUS COOKING**
Don't leave any food out at room temperature for more than two hours. Use sealable containers and don't over pack the fridge; the air needs to circulate to maintain the proper temperature. Baked goods should be thrown out within a few days.
- Tinsel-less Town**
Small children and pets love this sparkly, light-catching "toy" that's fun to play with, but if swallowed or accidentally wrapped around them it can be very dangerous.
- Furries shouldn't feast**
By now you know not to feed your pets chocolate or anything sweetened with xylitol but pets have a way of sniffing out yummy treats. Keep your pets away from the table and unattended plates of food and be sure to secure the lids on garbage cans.
- HURSTLE & BUSTLE**
Shop during daylight hours whenever possible. If you must shop at night, park closer to the stores or near a light post so when you return you are visible in a well-lit area.
- WRAPPING PAPER woes**
Don't burn used wrapping paper as it may cause intense flash fires. Throwing it out adds waste, so consider recycling or repurposing it instead.
- twinkletwinkle**
Do not connect more than three miniature light strings together. Cords should not be run under carpets or tacked-up with nails or staples.
- NOT SO merry matches**
The number of fires caused by children playing with fire goes up significantly during the holidays. Keep matches and lighters out of sight and out of kid's reach. Make sure you buy a "child resistant" lighter.
- CHRISTMAS TREE**
Natural trees always involve some risk of fire. To minimize risk, get a fresh tree and keep it watered at all times. Do not put the tree within three feet of a fireplace, space heater, radiator or heat vent.
